

**TYENDINAGA MOHAWK COUNCIL MINUTES
MAY 8, 2017**

A meeting of the Tyendinaga Mohawk Council was held on Monday, May 8, 2017 at 5:00 p.m. in the Council Chambers for Local Business.

Present: Chief R. Donald Maracle
Councillors: Stacia L. Loft (joined via phone), Carl E. (Ted) Maracle, Douglas E. Maracle and Debra A. Vincent.
Staff: David Souliere, CAO; and Angela Maracle, Senior Director of Operations.

Council had a discussion about medical marijuana and a statement drafted for distribution to the community.

MOTION #1: Moved by Debra A. Vincent, seconded by Douglas E. Maracle that David Souliere, CAO, contact the Police about having their contact information being added to the draft statement.

Carried.

The draft statement and Q & A's from the Government of Canada's website are to be brought back to Council for final review.

MOTION #2: Moved by Debra A. Vincent, seconded by Carl E. (Ted) Maracle that in reference to Motion #10 of the May 1, 2017 Minutes, an information session be organized for the community to walk through and gather information and ask questions instead of having a panel discussion.

MOTION #3: Moved by Douglas E. Maracle, seconded by Carl E. (Ted) Maracle to approve signing the Indigenous and Northern Affairs Canada Amending Agreement No. 0009 for:

- Education – New Paths for Education for \$8,750.00
- Social Development – Income Assistance Special Needs for \$3,500.00

MOTION #4: Moved by Douglas E. Maracle, seconded by Debra A. Vincent to approve signing the Association of Iroquois and Allied Indians Memorandum of Agreements 2017-2018 for:

- Aboriginal Fetal Alcohol Spectrum Disorder/Child Nutrition Program for \$18,596.14;
- Aboriginal Diabetes Education Prevention/Promotion Project for \$9,562.50;
- HIV-AIDS Strategy Program for \$3,298.20;
- Health Consultation Program for \$2,250.00.

William P. and Doug Brant attended Council regarding a response to the request to purchase three lots from MBQ on Iva's Road.

MOTION #5: Moved by Carl E. (Ted) Maracle, seconded by Debra A. Vincent to approve applying for funding to do a land use study.

Carried.

MOTION #6: Moved by Douglas E. Maracle, seconded by Debra A. Vincent to approve selling three lots to William P. Brant on Iva's Road for \$1,500 per lot due to the length of time it's taken to get a response (first attended Council on October 14, 2015).

Carried.

MOTION #7: Moved by Debra A. Vincent, seconded by Stacia L. Loft that no band held land will be sold, effective immediately, only under exceptional circumstances as determined by Council, until a land use study is completed.
